




**Number**                      **001874 - Percent of projects funded by the 2003 and 2005 funding packages completed on-budget**

Activities include supporting the department’s fish passage commitments and sustainable transportation objectives, obtaining statewide environmental approvals and permits , setting environmental compliance expectations and improvements, implementing WSDOT’s stormwater permit, maintaining statewide environmental procedures, and providing statewide environmental leadership and issue resolution. This activity involves close coordination with external groups and governments that have environmental interests related to transportation.












Percent 001892 - Percent of major ferry terminal improvement projects completed on time






Percent 001896 - Percent of major ferry vessel construction and improvement projects completed on budget




**Percent 001902 - Percent of rail projects funded by the 2003 and 2005 funding packages completed on-budget**


