**Facilities Portfolio Management Tool (FPMT) Project News:** System go-live is right around the corner!

The project team has begun planning for training and developing the user guide. OFM conducted a readiness assessment to inform training. Thank you to everyone who provided feedback. We received responses from over forty agencies, which were predominately positive and very informative. Agencies provided input on their knowledge of the project and its impacts. OFM will use the feedback from

the survey to coordinate communication and outreach and develop training materials.

## Agency Facilities Forum Presentation:

The FPMT project team provided a demonstration of the fully configured system at the May 11<sup>th</sup> Agency Facilities Forum held at DES headquarters.

The demo included an overview of system navigation, map features and a discussion of state business processes for reporting FIS. Agencies had an opportunity to see the process for adding and editing facilities data, reviewing data validation features and reporting.



About forty attendees viewed the demo at the Agency Facilities Stakeholder Forum.
