

ORDINANCE NO. 2009 - 737

AN ORDINANCE ANNEXING TO AND WITHIN THE CORPORATE LIMITS OF THE CITY OF ASOTIN CERTAIN REAL PROPERTY AND PROVIDING FOR THE EFFECTIVE DATE HEREOF:

THE CITY COUNCIL OF THE CITY OF ASOTIN AT A REGULAR MEETING ASSEMBLED DO ORDAIN AS FOLLOWS:

Section I

A Petition for Annexation was filed by Tony Maiorana and others.

WHEREAS, a public hearing was held and Ordinance No. 2009- 725 was passed;

WHEREAS, the passage failed to include the Route 129 right-of-way.

Section II.

NOW THEREFORE, the following described real property, to-wit:

That portion of State Route 129 (P.S.H. No. 3) located in Lots 2 and 3 of Section 17, Township 10 North, Range 46 East, W.M., Asotin County, Washington, lying Northerly of its intersection with the East line of the Southeast Quarter of said Section 17 being the City of Asotin Corporate Limits and lying Southerly of its intersection with the Northerly line, extended Easterly of the following described Parcel 3 as per Ordinance No. 2008-725, Instrument No. 30811, Records of Asotin County, Washington:

Beginning at a point where the West right-of-way line of P.S.H. No. 3 intersects the East boundary line of Baumeister Addition to the Town; thence Northerly along the West right-of-way line of P.S.H. No. 3 for a distance of 750 feet; thence South 89°50' West for a distance of 130 feet, more or less, to a point on the East right-of-way line of the County Road; thence Southerly along said right-of-way line for a distance of 900 feet, more or less, to its intersection West boundary line of said Baumeister Addition; thence North 23°37' West along said West boundary line for a distance of 360 feet, more or less; thence South 68°37' East along the Easterly boundary line of said Baumeister Addition for a distance of 236.0 feet; thence South 45°37' East for a distance of 104.3 feet to the true place of beginning.

is hereby annexed to and within the incorporated limits of the city of Asotin, Washington.

Section III.

This Ordinance shall be in full force and effect five days from and after it's passage, approval and legal publication.




