## **ORDINANCE: 1405**

An Ordinance amending Ordinances 1145, 1173 and 1174 to correct the legal description of real property annexed to the City of Cle Elum for municipal purposes.

**WHEREAS,** in 2001 and 2002, the City annexed certain City-owned real property to the City for municipal purposes pursuant to RCW 35.13.180; and

**WHEREAS,** the Washington State Office of Financial Management notified the City that Ordinances 1145, 1173 and 1174 contained incorrect legal descriptions of the real property subject to the annexation; and

**WHEREAS**, the City Council desires to amended Ordinances 1145, 1173 and 1174 to reflect the correct legal description;

**NOW THEREFORE,** THE CITY COUNCIL OF THE CITY OF CLE ELUM, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section I: Ordinances 1145, 1173 and 1174 are hereby amended by replacing the legal descriptions with the following legal descriptions specifying those areas of unincorporated Kittitas County annexed to the City of Cle Elum pursuant to RCW 35.13.180 for municipal purposes:

NORTHWEST QUARTER OF SECTION 36; THENCE NORTH 89°13'55" WEST ALONG SAID NORTH BOUNDARY OF SAID NORTHWEST QUARTER, 365.86 FEET; THENCE SOUTH 00°40'21" WEST, 579.93 FEET; THENCE SOUTH 89°13'55" EAST, 695.19 FEET; THENCE SOUTH 00°40'21" WEST, 654.40 FEET TO THE NORTHERN RIGHT OF WAY OF INTERSTATE 90 (1-90); THENCE ALONG SAID NORTHERN AND WESTERN RIGHT OF WAY BOUNDARIES THE FOLLOWING COURSES AND DISTANCES; SOUTH 72°36'06" EAST, 127.71 FEET TO THE BEGINNING OF A CURVE TO THE RIGHT HAVING A RADIUS OF 5905.00 FEET; THENCE ALONG SAID CURVE TO THE RIGHT AN ARC LENGTH OF 725.89 FEET, THROUGH A CENTRAL ANGLE OF 7°02'36"; THENCE SOUTH 65°50'00" EAST,

516.80 FEET; THENCE SOUTH 66°47'45" EAST, 446.89 FEET; THENCE NORTH 66°49'30" EAST, 278.42 FEET; THENCE NORTH 31 °5 I'45" EAST, 399.33 FEET; THENCE NORTH 23°00'45" EAST, 427.79 FEET TO THE TRUE POINT OF BEGINNING AND TERMINUS OF SAID LINE.
