## Legislative Exceptions to the Economic Feasibility Study (EFS) Requirement

State agencies are required to submit an EFS to the Office of Financial Management for approval prior to accepting or disbursing electronic payments (refer to *SAAM* Chapter 40 for specific requirements). However, an EFS is not required if either state or federal statute mandates or allows acceptance or disbursement of electronic payments. The following table shows the current legislative exceptions to the EFS requirement.
