



As of April 2024, FPMT's accounting functionality and integration with the Agency Financial Reporting System (AFRS) have been removed. Moving forward, agencies will meet their federal Governmental Accounting Standards Board (GASB) reporting requirements in a new system called [DebtBook](#). This job aid provides a high-level overview of FPMT updates, including changes to table names, user role permissions, and business process wizards.

### High-level Change Overview

#### AFRS Integration

- There is no longer an integration between FPMT and AFRS.

#### System Roles and Permissions

- The Accounting role has been removed. There is now one agency editor role with permissions to all wizards and limited manual edit rights.
- Users who only had the Accounting role have been transitioned to Read Only accounts.

#### Table Names and Fields

- The names of some existing tables have changed.





#### Wizards

- All wizards are now a single-step process.
- Users will create a new space table as part of the lease and receivable lease renewal processes.
- The Lease Review and Receivable Review wizards have been updated and allow users to edit all tables associated with an agency's leased and receivable facilities.
- A new Owned Facility Review wizard allows users to edit all tables associated with an agency's owned facilities.

#### Reports

- The facilities and lease contract QA reports have been combined into a single report.
