SUBJECT: SAAM TECHNICAL CORRECTION – EFFECTIVE NOVEMBER 1, 2005

The online version of Chapter 15, Personal Services Contracts, Sections 15.10, 15.20, and 15.30, in the *State Administrative & Accounting Manual* (SAAM) has been revised. A print copy of these changes will be included with the January 2006 update.

Changes to the following sections become effective **November 1, 2005**:

• Section 15.10, Subsection 15.10.20.h (<a href="http://www.ofm.wa.gov/policy/15.10.htm">http://www.ofm.wa.gov/policy/15.10.htm</a>) - Contracts for Expert Witness Services

Revised the language to clarify that the exemption includes expert witnesses for administrative hearings.

◆ Section 15.20 (<a href="http://www.ofm.wa.gov/policy/15.20.htm">http://www.ofm.wa.gov/policy/15.20.htm</a>) - Competitive Procurement Requirements

Minor editing and clerical changes to the language in Subsections 15.20.30.b, 15.20.30.d, 15.20.40, and 15.20.60.c.

• Section 15.30 (<a href="http://www.ofm.wa.gov/policy/15.30.htm">http://www.ofm.wa.gov/policy/15.30.htm</a>) - Filing, Record Keeping and Reporting

Minor editing and clerical changes to the language in Subsections 15.30.10.e, 15.30.40.c.(3), 15.30.40.c.(5), 15.30.50.c.(1), and 15.30.50.c.(4).
