## SUBJECT: REVISIONS TO CHAPTER 75 UNIFORM CHART OF ACCOUNTS

Attached is a complete revision to Chapter 75, Uniform Chart of Accounts of the state of Washington's *State Administrative and Accounting Manual* (SAAM). The effective date of this revision is July 1, 2000. The materiality levels contained in 75.30.30, Roll-up Funds and Account Groups, are as of June 30, 1999. These changes include all legislative action through the 2000 Legislative Regular and Special Sessions and the Office of Financial Management (OFM) administrative changes.
