SUBJECT: REVISIONS TO CHAPTER 80: ACCOUNTING POLICIES AND

CHAPTER 85: ACCOUNTING PROCEDURES

We have revised Chapter 80: Accounting Policies and Chapter 85: Accounting Procedures of the state of Washington's *State Administrative and Accounting Manual* (SAAM). These changes are effective July 1, 2000. Please replace the affected pages in your manual with these revisions.

Major Changes to the regulations include:

Subsection 80.30.86 (http://www.ofm.wa.gov/policy/80.30.htm - 80.30.86) Using standard or other accounting forms, Subsection 85.32.40 (http://www.ofm.wa.gov/policy/85.32.htm - 85.32.40) Payment processing, Subsection 85.38.20 (http://www.ofm.wa.gov/policy/85.38.htm - 85.38.20) Statutorily canceled warrants, and Subsection 85.54.50 (http://www.ofm.wa.gov/policy/85.54.htm - 85.54.50) Receivable collection procedures. A privacy notice was added as notification to agencies that personal information of citizens and employees collected by agencies must be safeguarded and disposed of in a manner consistent with Executive Order 00-03, April 25, 2000, and RCW 42.17.310.

Subsection 85.36.20 (http://www.ofm.wa.gov/policy/85.36.htm - 85.36.20) **Disbursement mechanisms.** Added language to provide that purchase cards are not to be used to pay for transactions between state agencies.

Subsection 80.30.30 (http://www.ofm.wa.gov/policy/80.30.htm - 80.30.30) Cash, cash equivalents, and investments policies, Subsection 85.52.20 (http://www.ofm.wa.gov/policy/85.52.htm - 85.52.20) Short-term investments, and Subsection 85.52.30 (http://www.ofm.wa.gov/policy/85.52.htm - 85.52.30) Non-current investments were revised to clarify the valuation and reporting of current and non-current investments.
