1. Section 2.2 is amended as follows:

2. Section 3.2 is amended as follows:

3.2 Qualifications/Experience (Section 2 of Proposal)

<u>General Requirements</u>: This section of the Proposal must contain information that will demonstrate to the evaluation committee the Bidder's understanding of the types of services proposed, the Bidder's ability to accomplish them, and the ability to meet tight timeframes. This section must also demonstrate the capabilities of the Bidder's staff to perform the services.

<u>Numbering of Responses</u>. Please number each response so that it corresponds to the question number. The response must begin with a restatement of the question followed by the Bidder's response to the question. A reference to another section will not suffice, each answer must stand alone.

<u>Attachments</u>: Attachments must be labeled and the question number to which it responds must be indicated.

<u>Points Awarded for Responses</u>. The number in parentheses after each question or requirement represents the maximum number of points that may be awarded for the Bidder's response to that question or requirement.

a. Firm Qualifications and Experience (25 points)

- 1) Describe the firm's recent experience (within the last 5 years) with evaluations. **(5 points)**
- 2) Describe the firm's recent experience (within the last 5 years) with national service programming such as AmeriCorps. **(5 points)**
- 3) Describe the firm's recent experience (within the last 5 years) with applying an equity lens to your evaluation work. **(5 points)**
- 4) Describe the firm's recent experience or training in (within the last 5 years) with workforce development. **(5 points)**
- 5) Describe the firm's experience writing clear and comprehensive reports with well justified, data-driven recommendations. **(5 points)**

b. Staffing Qualifications and Experience (15 points)

- 1) Provide a description of typical project team structure and internal controls to be used during the course of the project, including any subcontractors. **(5 points)**
- 2) Provide the name and a resume of the person who will be the lead contact for this evaluation. **(5 points)**
- Provide names and resumes for other staff, which includes information on the individuals' particular skills related to evaluations; education, experience, significant accomplishments and any other pertinent information. (5 points)

c. Work Plan (50 points)

Submit a Work Plan describing how you would accomplish the Scope of Work.
