SUBJECT: 2025-27 Biennial Budget Information Technology Decision Packages

As outlined in the Office of Financial Management's (OFM) <u>2025-2027 Biennial Operating Budget Instructions Chapter 10</u>, agencies are required to consult with WaTech before submitting an IT related Decision Package (DP) request to OFM.

Our focus is to partner with agencies during consultations and help them create the most effective and quality DP by ensuring there is statewide and agency strategic alignment with clearly defined outcomes. The consultations will improve WaTech's understanding your DPs assists WaTech in the review and scoring the submitted DPs and subsequent funding recommendations to OFM and the Legislature.

WaTech Business Relationship Managers are coordinating consultations now through Aug. 31, 2024. WaTech will send a meeting notice for the DP consult to your agency. Feel free to forward the meeting notice to other business leaders within your agency to ensure business and leadership alignment with our respective agency strategic roadmaps and associated investments. Together we will be able to assure OFM and all enterprise stakeholders that we are submitting the best, most efficient, and optimized investment proposals for their consideration.

Along with the consultation requirement, agencies are required to:

- Complete an IT Addendum on all Decision Packages (DP) with an IT cost component.
- Complete the <u>IT fiscal estimate workbook</u> in the IT Addendum (for all DPs with an IT cost component) and submit it as an attachment to the DP.
