Enclosed is the capital budget request from the Office of the Secretary of State (OSOS) to consider for the 2023-25 biennium. Below are the highlights of our capital projects for consideration.

- 1. Archives Minor Works. Due to supply chain challenges in the last biennium, the OSOS is requesting a reappropriation to complete the facility upgrades initiated in the 2021-23 biennium. Over the last biennium, the OSOS upgraded the smoke detection system at Central Washington University by replacing it with a code compliant system. The remaining phase of this request is upgrading the mobile shelving's electrical system at Bellevue College. The OSOS anticipates completing this work before the end of the current biennium, however a contingent reappropriation is submitted.
- 2. **Archives Capital Minor Works.** The OSOS identified a series of projects necessary to preserve the archival facilities around Washington state. These projects will improve safety, safeguard vital documents, bolster security measures, and increase operational efficiency.
- 3. Library-Archives Building. The OSOS requests to reappropriate funding from the previous biennium to continue efforts to construct the new Library-Archives Building in the next 2023-25 biennium. Permitting requirements due to the presence of pocket gophers and the impact of inflation on construction costs have extended the construction timeline. The future building will co-locate and consolidate services into a single facility and will benefit legislators, historians, state employees, out of state visitors, and Washingtonians.

As Archives facilities age, minor maintenance and end-of-life replacement projects must be completed to ensure the continued preservation of the State's archival collections and the safe and efficient operability of the facilities. All Archives branch facilities are located on state university campuses and are maintained by the host university's facility staff.

#### **Project Description**

What is the problem/opportunity? What will the request produce or construct (predesign/design of a building, additional space, etc.)? How would the request address the problem or opportunity identified in question 1? What would be the result of not taking action?

OSOS requests funds to initiate and complete various projects that improve efficiency, employee safety, and protect archival assets. Please see subproject pages for details.

Lighting Upgrades (Bellingham & Ellensburg) -- Replacing existing lighting with LED fixtures will reduce energy consumption and the impact of fluorescent lighting on archives collections.

Dry Fire Sprinkler Valve Replacement (Ellensburg) -- The current system has been in place since 1993 and needs to be updated per annual Kittitas Valley Fire and Rescue inspections. This protects employees and archival records.

Ceiling Tile Replacement (Ellensburg) -- Water leaks and normal wear and tear have left ceiling tiles in staff areas stained and broken. Replacing these tiles will restore to standard designs and colors. Replacing water damaged tiles will increase public confidence that archives are properly managed and stored.

Carpeting Replacement (Ellensburg) -- Carpeting is 30 years old. The buckling in the carpeting presents tripping hazards for employees and difficulties moving heavy carts. Replacing this carpet promotes employee safety and operational efficiency.

Security Upgrades (Cheney) -- Third party review revealed areas of improvement. Access control system has been in place for 20 years and is out of date. Additional security cameras and lights are needed to observe and record areas identified as potential weaknesses. Physical barriers are also necessary to prevent access to essential facility equipment. These upgrades promote employee safety and protect archival assets.

HVAC Unit Replacement and Repairs (Olympia) -- The HVAC unit currently maintaining the temperature and relative humidity of archival records has failed and three others are operating under capacity. Requesting to replace on HVAC unit and repair the other three units. This request improves protections for archival assets.

Increase Collection Space Availability (Bellevue) -- The Puget Sound Regional Branch Archives is over capacity for box storage. Currently, OSOS is using overflow storage in Olympia to meet this need. This request will replace static shelving with mobile shelving. In conjunction with other operational projects, this effort will increase storage capacity for the next 10 years. This request will improve operational efficiency.

Local government agencies and the public rely on both branches to preserve and provide timely access to their permanent records. Building improvements will ensure staff can retrieve necessary records safely and efficiently.

To reduce the impacts of outdated fluorescent lighting on the archives collection and to reduce energy consumption in archives facilities located in Bellingham and Ellensburg, OSOS requests funding for LED lighting and occupancy sensors.

#### **Project Description**

### What is the problem/opportunity? What will the request produce or construct (predesign/design of a building, additional space, etc.)?

Fluorescent lighting emits harmful UV light that can damage the archival collection over time. Fluorescent lighting also contains harmful chemicals like mercury. This request would replace the fluorescent lighting with LED lighting, which emits no UV light. LED lighting also has no harmful chemicals and also lasts longer and is cheaper to run than its fluorescent counterpart.

#### When will the project start/end?

Bellingham - Start and finish FY25 Ellensburg - Start FY24, finish FY25

#### How would the request address the problem or opportunity identified? What would be the result of not taking action?

If no action is taken, the current fluorescent lighting risks damaging original documents representative of Washington state's history. Inaction also results in Washington taxpayers continuing to pay for higher energy costs to preserve historical archives.

#### What alternatives were explored? Why was the recommended alternative chosen?

No appropriate alternatives exist that achieve energy cost savings combined with eliminating UV light exposure and lighting requirements.

Local government agencies and the public rely on both branches to preserve and provide timely access to their permanent records. The energy savings generated by upgrading the lighting benefits Washingtonians financially.

The current fire protection sprinkler system has been in place since original construction in 1993. The National Fire Protection Association denotes that the existing valve is not compatible with the available components, rendering the system unreliable. The Kittitas Valley Fire and Rescue noted this deficiency during its annual inspection. This deficiency presents physical damage risk to OSOS employees and state archives. This request will correct the identified deficiency in the fire protection system by replacing the outdated sprinkler valve.

#### How would the request address the problem or opportunity identified? What would be the result of not taking action?

If no action is taken, the unreliable fire protection system could be ineffective at extinguishing a fire. Vital records and original records of historical importance stored at the facility risk destruction. Inaction also puts employees and customers at risk in the event of a fire. Lastly, inaction facility will remain out of compliance per the fire department's annual inspection standards.

#### **Project Summary**

To protect vital records, build public confidence, and to maintain the archives facility located in Ellensburg, OSOS requests funding to replace broken and water damaged ceiling tiles.

#### **Project Description**

### What is the problem/opportunity? What will the request produce or construct (predesign/design of a building, additional space, etc.)?

The current ceiling tiles in the archives facility located at Central Washington University have been in place since the facility's construction in 1993. Over those 30 years, water leaks and normal wear and tear have left the ceiling tiles located in public areas and select staff areas stained and broken. Ceiling tiles are an important element to fire protection and they are designed as a layer of fire break. Damaged ceiling tiles are less effective at providing fire protective measures. Water marks on ceiling tiles also make it difficult to identify future water leaks sooner, which can lead to moldy conditions. This presents health risks to OSOS employees and physical damage risk to documents. These ceiling tiles also don't portray that vital records are safe if they are stored in the archives facility and they erode public trust. This request replaces all ceiling tiles to protect OSOS employees, vital documents, and restore public confidence in the archives facility.

Start and finish FY25

How would the request address the problem or opportunity identified? What would be the result of not taking action? If no action is taken, future leak detection will be more difficult, which can lead to mold. Mold not only puts OSOS employees at risk, but also risks ruining vital documents. Inaction also contributes to degrading the facility's fire protection since broken ceiling tiles are less effective at acting as a fire barrier. Inaction also means that the public will continue to question whether or not the facility is suitable to house the state's vital records.

#### What alternatives were explored? Why was the recommended alternative chosen?

The alternative to this request is replacing ceiling tiles as they break. However, this practice over 30 years led to the presence of numerous variations in patterns and designs. This request reflects OSOS's care for entrusted documents and the facility that houses them.

#### **Project Summary**

To ensure the protection of Washington state's archival collections located on the campus of Eastern Washington University and to address security vulnerabilities, OSOS requests funding to shore up security measures.

#### **Project Description**

### What is the problem/opportunity? What will the request produce or construct (predesign/design of a building, additional space, etc.)?

The current security system in the archives facility located in Eastern Washington University has been in place for the last 20 years. OSOS requested a third party security review, which identified several areas for improvement. The third party identified the access control system as a vulnerability and recommended modernization to meet best practices and security standards. The inspection also identified blind spots and recommended additional camera coverage and lighting to deter potential criminal behavior. Lastly the inspection highlighted the need for physical barriers to prohibit free access to essential facility equipment.

#### When will the project start/end?

Start and finish FY24

How would the request address the problem or opportunity identified? What would be the result of not taking action? If no action is taken, the facility will be vulnerable to theft and losing vital documents - some that are irreplaceable. If criminals exploit the blind spots in the security system's current form, recovering stolen items will also be difficult. This request significantly reduces the risk of criminal behavior by funding preventative security measures.

#### What alternatives were explored? Why was the recommended alternative chosen?

Integrating roving security checks with current employees was explored, but this would be at the expense of their primary duties. This alternative also doesn't effectively address criminal activity occurring after the standard work hours. This request is the best method to prevent unauthorized access to vital documents and the archives facility.

The current HVAC system at the Olympia archives facility is operating under expected capacity. DES inspected the HVAC system and determined that one HVAC unit has completely failed and identified three others that are operating under capacity. The HVAC system is critical to maintaining the proper environmental conditions with regards to humidity and temperature conducive to preserving vital documents stored at the facility. This request reflects the DES estimate to replace one failed HVAC unit and repair the three HVAC units operating under capacity in order to restore the facility to the proper environmental conditions.

#### When will the project start/end?

Start in FY24, finish FY25

#### How would the request address the problem or opportunity identified? What would be the result of not taking action?

If no action is taken, vital documents are at risk for damage. If the HVAC units in question continue to worsen, the facility will not be able to maintain the proper environmental conditions to preserve historical documents, which will accelerate deterioration. Addressing this problem now will reduce the chances of requesting emergency funds at a higher cost of replacing units versus repairing units.

The current carpets in the archives facility located in Central Washington University has been in place for the last 30 years. The carpets are worn, stained, and buckling. Other than the image old carpeting presents to the public, the buckling carpets are a tripping hazard to staff. Moving rolling carts over the current thick carpet is also challenging and can result in falling carts, which can both damage archives assets and OSOS employees. This request transitions the whole carpet system to a tile system, which will allow for efficient and affordable replacement by smaller sections if necessary. This new system will also allow for easier travel with rolling carts and reduced tripping hazards.

#### How would the request address the problem or opportunity identified? What would be the result of not taking action?

If no action is taken, OSOS staff and the public will continue to be exposed to tripping hazards as they move about the facility. The longer inaction is taken, the more difficult it will be for staff to move rolling carts throughout the facility and the greater the opportunity for falling carts and damage to archival assets. This request ensures that OSOS staff can perform their duties safely and efficiently.

Replacing the existing carpet with similar thick roll carpet was explored, however future carpet replacement is more difficult with this style. The proposed carpet tile is preferred because it has a lower profile conducive with carts and is more cost effective to replace in sections, should maintenance be required in the future.

The Puget Sound Regional Branch Archives facility located on the campus of Bellevue College is at capacity and cannot store additional archival boxes in its current form. To date, over 1,000 boxes of the archival collection have been relocated from Bellevue College to overflow storage in Olympia. In conjunction with other operational projects, replacing static shelving with mobile shelving will increase Bellevue's box storage capacity by 3,500. This increase will sustain the projected storage needs for the next 10 years before an additional storage space will be needed.

#### How would the request address the problem or opportunity identified? What would be the result of not taking action?

If no action is taken, vital documents will continue to get transferred to other archives facilities. This requires logistics coordination and increases the archives carbon footprint. This solution ensures that the public has access to vital documents and reduces the OSOS carbon footprint and reduces transportation related costs.

#### **Project Summary**

OSOS requests to reappropriate funding for the design of the new Library/Archives building funded in the 2018 Capital Budget (Chapter 2, Laws of 2018). Due to permitting issues beyond our control and extension of design timelines, we will require a reappropriation to finish the design. The completed building will allow OSOS to co-locate and consolidate services into a single facility. The need for a new facility has been critical for the past decade. Our operational and design needs as outlined in the predesign have not changed, just the design timeline.

#### **Growth Management impacts**

Tumwater's Comprehensive Plan also calls for a new town center. The plan identifies the same 190 acres of land, located between Tumwater Boulevard, Israel Road, Nicholas Street, and Interstate 5, as the preferred area for developing the Tumwater Town Center. The Comprehensive Plan seeks to create an environment that encourages pedestrian activity and interest along the streets. Land uses envisioned for the area include mixed use commercial and residential, high-density residential, retail, educational, and civic services, parks, pedestrian plazas, and other open space areas. In addition to the major goal of replacing the town center lost by the construction of Interstate 5, other goals of this Tumwater Town Center plan are to: 1. Create a mixed-use Town Center consisting of commercial developments of office, retail, and service businesses; residential, educational, civic services; support facilities; and public assembly facilities. 2. Site and develop new professional office facilities to build a "critical mass" of employment sufficient to encourage high-capacity public transit and discourage the use of single-occupant vehicles. 3. Create open space and park areas to preserve the area's natural resources and beauty. Both the City of Tumwater and Port of Olympia, in accordance with planning done by the Thurston County Regional Planning Council have all recommended moving industrial zoning further south and away from the gateway corridor of the intersection of New Market and Tumwater Boulevard. The construction and operations of the new Library Archives facility would fit in with the new vision for Tumwater City Center providing a long-term public-oriented facility at the gateway to the newly-revitalized yet historic city of Tumwater. The Library-Archives Building at either the Tumwater. Lacey, or GA site meets the county compliance planning requirements of RCW 36.71A.040 and is consistent with the comprehensive plans of Thurston County, the cities of Lacey, Olympia, and Tumwater, and the Port of Olympia. Bringing together seven different programs from seven locations into one central building brings the new facility into strict compliance with the goals of the growth management acting to centralize and collocate organizations of similar function into a single area or facility.
