AES	Climate	Reduction to one-time Appropriation for Agricultural Sequestration Grants (CCA, Capital Budget)	1,000,000		CCA	WSDA received a \$5 Million appropriation in the 2024 Supplemental Capital budget for a grant program to support agricultural carbon sequestration projects. Funding cannot be used until 2 January 1, 2025. This option would reduce funding for implementation of the grant program by 20%. WSDA has already been planning for grant implementation on January and there is a high demand for these grants.
AES	Climate	Delay Climate Lead Position	131,000		CCA	WSDA received funding for a Climate Lead in the 2024 Supplemental Budget. The funding is not effective until January 1, 2025. This option would delay hire and limit capacity to coordinate agricultural climate resilience strategies; maintenance of current activities will reduce capacity to implement soil health programs, which also support climate mitigation and resilience.
Plant Protection	Compost	One-time reduction to Appropriation for Compost Reimbursements	1,289,362		CCA	WSDA received a biennial appropriation to implement a program to reimburse farms for compost purchase and use in the organic materials management law; 2024 was the first year distributing compost reimbursements with roughly \$360,000 reimbursed to farms. For this next cycle, we have \$1,200,000 in contracts with farms out for signature. The amount shown for FY 25 is the remaining balance minus this potential obligation. As composting infrastructure and usage grows in future, and the program continues, we anticipate more interest and demand for reimbursements, with a rough estimate of \$2,250,000 estimated demand per year based on 300 growers seeking reimbursement at an average of \$7,500 per reimbursement. The FY 2025 proposed amount would still allow fulfillment of current contracts for the next growing season but would reduce administrative capacity, including soil testing costs.

This would reinstate the original funding source for this work and would not have any impacts to program implementation.

Plant Protection	Pest	One-time reduction to Japanese Beetle Proviso Funding	200,000		GF-S	This one-time reduction in expenditures in FY 2025 for Japanese Beetle eradication in the Grandview, Wapato, and Pasco region would reduce acres treated in FY 2025.
Plant Protection	Pest	Delay Weed Specialist Position	79,000		GF-S	WSDA has a vacant Weed Specialist position in the Plant Protection Division; this option would delay hire until July 1, 2025 and is based on 8 months (November 2024-June 2025) salaries and benefits for an Environmental Specialist 4, Step M. Delay of hire would reduce capacity for noxious weed management coordination.
Directors Office	Equity	One-time funding reduction in equity programs.	100,000		GF-S	This savings is due to current biennium position vacancies, WSDA estimates savings in FY 2025 funding dedicated to PEAR, DEI and HEAL. This is a one-time savings, the agency does not anticipate this savings in the future biennium's as this funding is critical to ensure we are able to do the important required ongoing work in these areas.

Department workload related to negotiations has not been significant in recent years. We assume we could absorb the administrative costs related to supporting any future negotiations for these added products.
Directors Office	Regional Markets/Farm to School	CSFRF Local Food Infrastructure capacity	276,261		CSFRF	 23-25 Funding is provided to support operations across the emergency food system, such as food processing, storage, transportation, supply chain linkages, and related technical assistance. This is the estimated balance that will not be used. No impact.
AES	Pesticide	One-time funding reduction for Nitrate Pollution	100,000		MTCA	 23-25 Ongoing funding is provided to support work to reduce nitrate pollution in groundwater from irrigated agriculture in the Lower Yakima Valley. Establishment of this activity took longer than expected, creating initial vacancy savings. Now that the program is established, we 2 anticipate spending down some of the earlier savings. Despite this, we anticipate leaving \$100,000 unspent. We do not anticipate future savings now that the program is established. Because the savings are related to earlier vacancies, there is not a significant impact to this option.

The impact would be suspension of new contracted research for 2 management alternatives for burrowing shrimp.
Food Safety and Consumer Services	Food Safety	Dairy Inspector Vacancy	63,000		GF-S	A lead Dairy Inspector position is projected to be vacated at the end of December. This option would delay re-hiring until July 1, 2025. Cost savings estimated is based on 6 months Food 2 Safety Compliance Specialist 5, step M. This is a critical position for public health, and the food safety programs anticipate a reduction in federal funding, which may make this GF-S funding necessary to maintain core food safety operations.
