Mattawa annexation ordinance 21-664 is corrected and superseded by Mattawa 21-665. Mattawa 21-664 does not change any boundaries. Both 21-664 and 21-665 are amendments to Mattawa annexation ordinance 480.

ORDINANCE NO. 21-664

AN ORDINANCE OF THE CITY OF MATTAWA AMENDING ORDINANCE 480 ANNEXING CERTAIN LANDS KNOWN AS THE THOMAS/EVANS ANNEXATION TO THE CITY OF MATTAWA.

THE CITY COUNCIL OF THE CITY OF MATTAWA, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Annexed Lands. Pursuant to RCW, Chapter 35A.14 and RCW Title 35A, and RCW 35A.21.210, the City of Mattawa does hereby annex the following described real estate situated in Grant County, Washington and revise its corporate boundary to include within the corporate limits of the City of Mattawa section of County Road 24 SW, and correct Ordinance No. 480:

Pat-Chee Subdivision Lots 1,2,3,4 and 5 per the plat therof recorded with the Grant County Auditor in Book 11 of Plat, Pages 64-69 together with the following: Beginning at the Southwesterly corner of said Lot 5, thence Easterly to the Eastern right-of-way of State Route 243, thence North along said Eastern right-of-way boundary to the North boundary of the right-of-way of county Road 24 SW, thence West to the Northwestern corner of said Lot 1.

Section 2. Zoning and Regulation. The City's comprehensive plan shall be adopted for the area annexed by this ordinance, and these lands shall be subject to all City regulations. This area shall be zoned Commercial -2 until its designation is changed.

Section 3. Existing indebtedness. This entire area to be annexed and described above, shall be required to assume all existing City indebtedness. No portion of the property annexed herein shall be released from any outstanding indebtedness levied against it prior to this annexation.

Section 4. Filing. A copy of this ordinance shall be filed with the Board of County Commissioners of Grant County, Washington.

Section 5. Extension of Franchise. By operation of law, there is hereby granted to any franchise garbage hauler serving any portion of the annexed property a ten year franchise to continue the collection and disposal of garbage and other solid

waste for the areas served on the date of the adoption of this ordinance.

Section 6. Effective Date. This annexation shall be effective five days after passage of this ordinance and publication of its summary.
