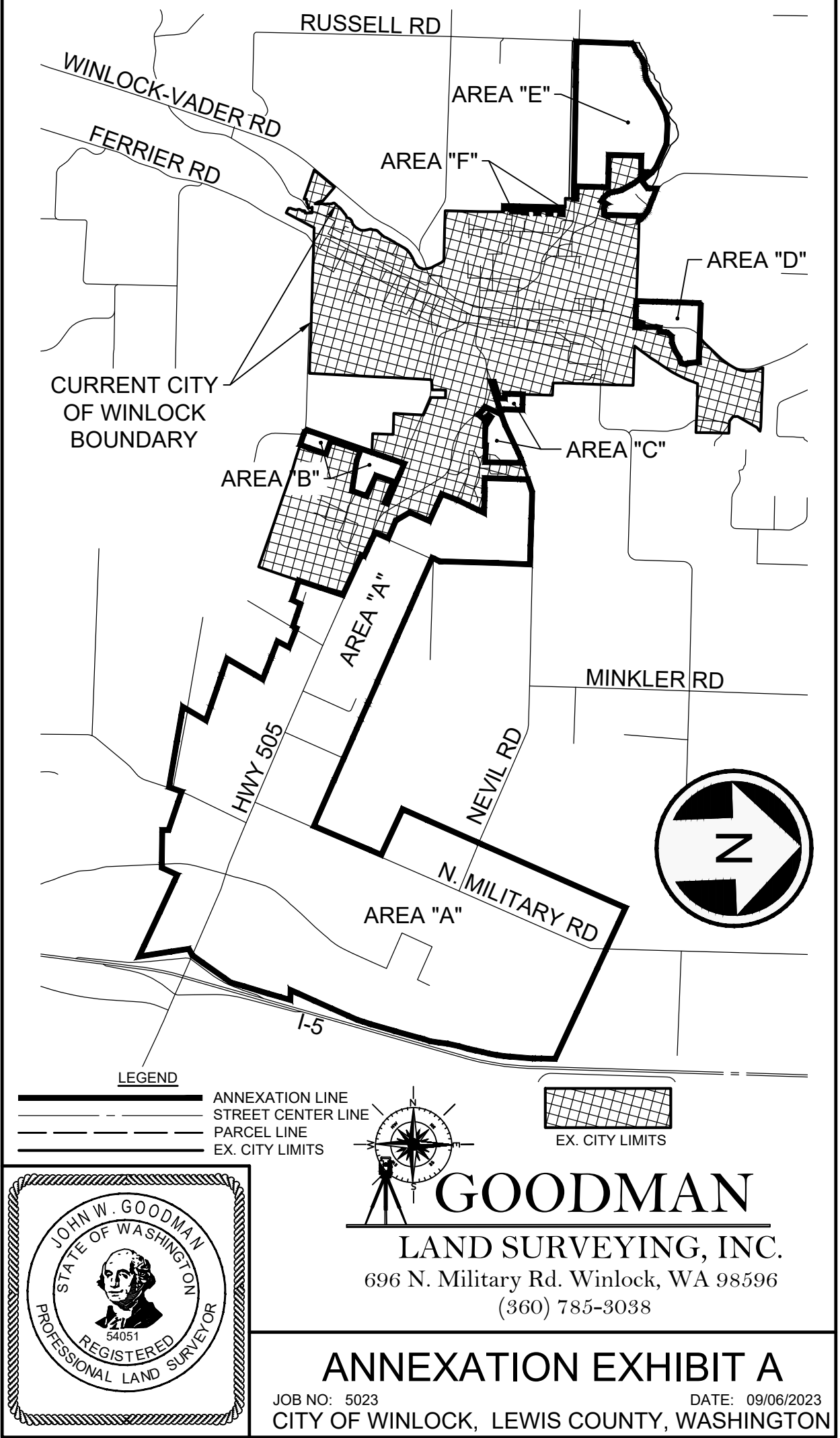


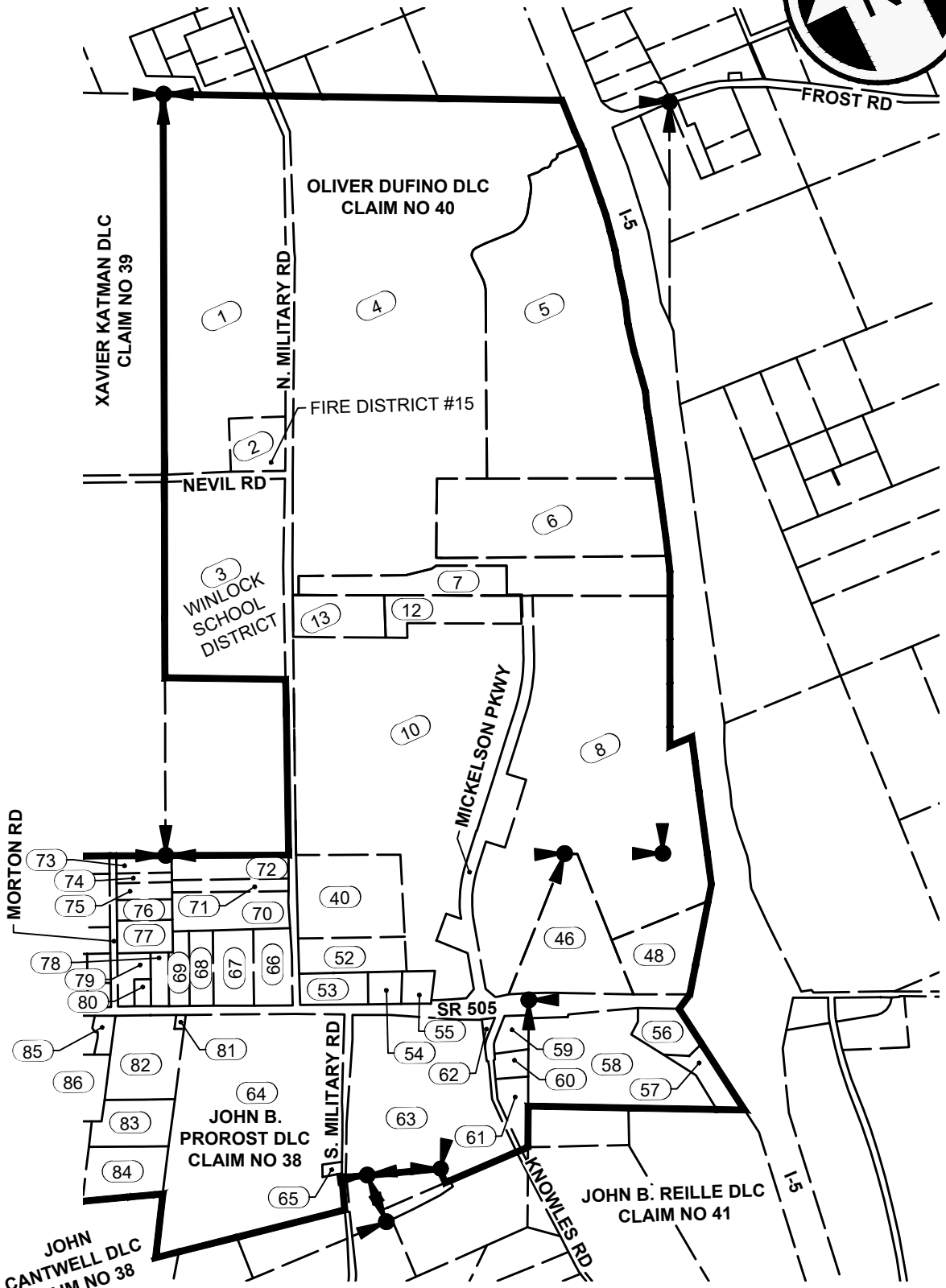
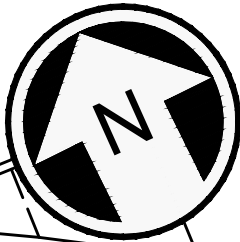

LEWIS COUNTY, WASHINGTON

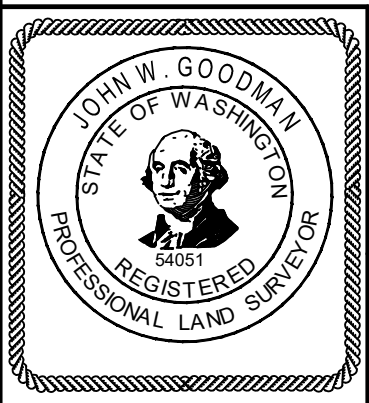

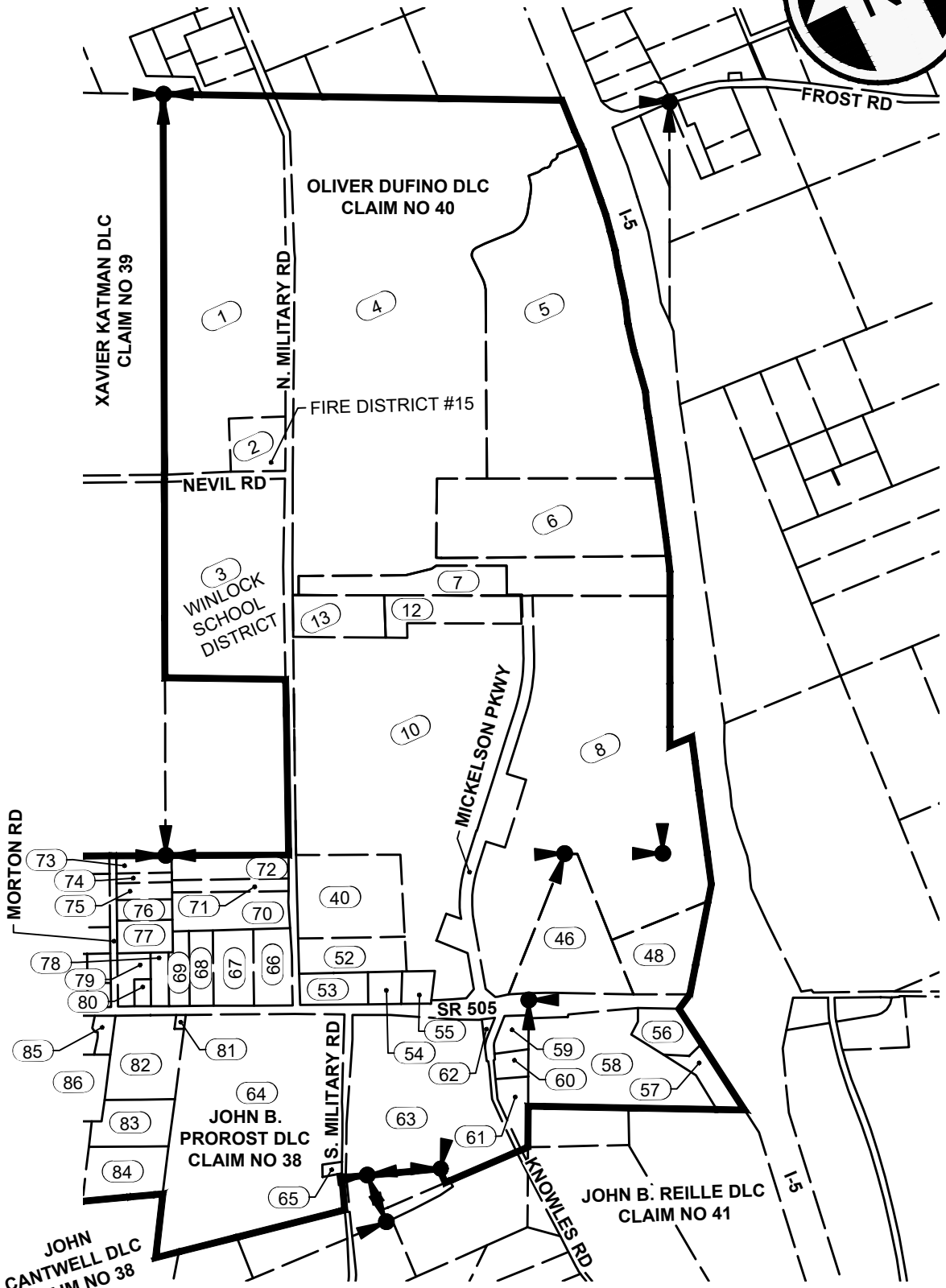
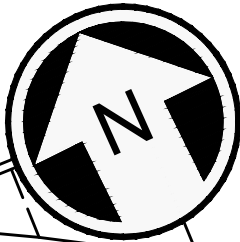

LEWIS COUNTY, WASHINGTON

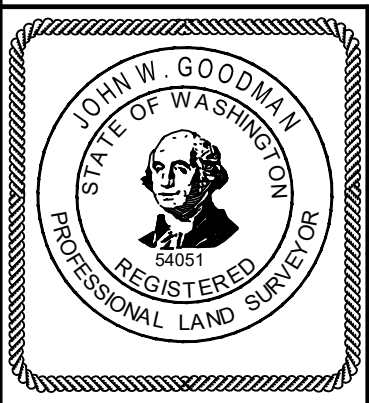

LEWIS COUNTY, WASHINGTON



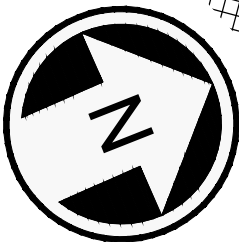
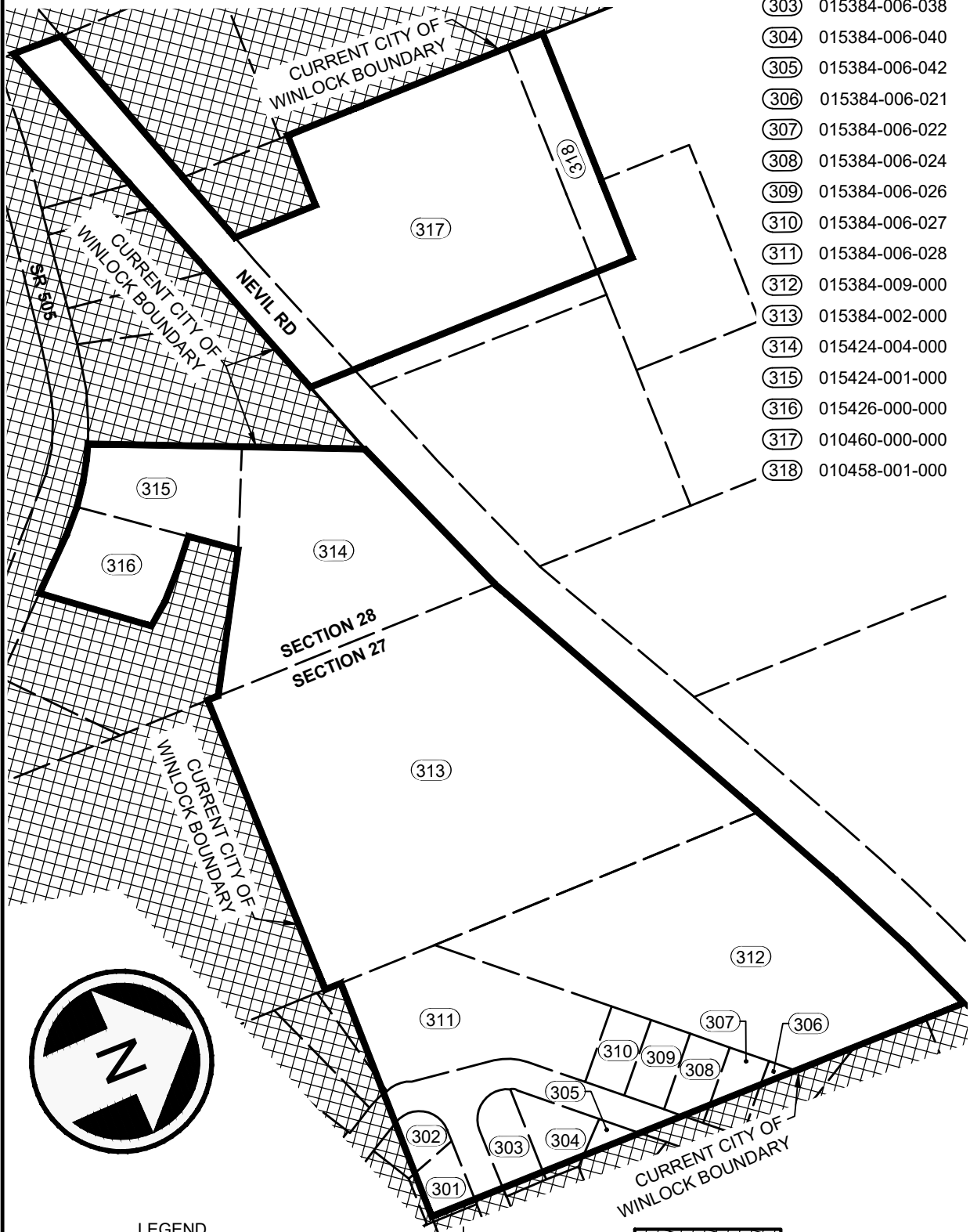
