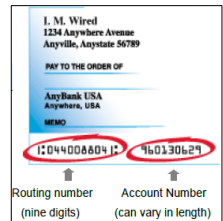

Waxaan ogolahay inaan u hogaansamo sharciyada NACHA (National Automated Clearing House Association, Ururka Lacag Is-weydaarsiga Elektarooniga ah ee Qaranka) ee la xidhiidha galitaankan.
