ORDINANCE NO. 16-477

AN ORDINANCE ACCEPTING THE TRANSFER OF JURISDICTION OVER A PORTION OF COUNTY ROAD R NW FROM GRANT COUNTY, WASHINGTON TO THE CITY OF QUINCY, WASHINGTON CONTIGUOUS TO THE COMMONLY KNOWN REAL PROPERTY SAGELANDS ORCHARDS LLC PROPERTY.

WHEREAS this Ordinance deals with a portion of County Road R NW and Right-of-way described as follows (the "Roadway") and shown in Exhibit A Board of County Commissioners, Grant County, Washington Resolution No. 16-045-CC:

THAT PORTION OF R NW ROAD roadlog 93025 MP 0.693 to MP 1.05, located at the eastbound 11 NW roadlog 32780; of Section 12 T20N R 23 E.W.M. and Section 07 T20N R24 E.W.M., all in Grant County, Washington.

WHEREAS RCW 39.33.010 authorizes the State of Washington and its municipalities and political subdivisions to transfer real property rights on such terms and conditions as may be mutually agreed upon;

WHEREAS the Board of County Commissioners of Grant County, Washington has adopted Resolution No. 16-045-CC transferring jurisdiction of the Roadways to the City, to become effective upon the date the City passes an ordinance accepting jurisdiction of the Roadways;

The City Council of the City of Quincy, Washington, do ordain as follows:

Section 1. The City accepts the transfer of R NW ROAD and right-of-way roadlog 93025 MP 0.693 to MP 1.05, located at the eastbound 11 NW roadlog 32780; of Section 12 T20N R 23 E.W.M. and Section 07 T20N R24 E.W.M., all in Grant County, Washington. CONTAINING 2.639 ACRES MORE OR LESS

Section 2. This Ordinance shall be published in the official newspaper of the City of Quincy and shall take effect and be in full force five (5) days after passage and publication.

WHEREAS, in accordance with RCW 39.33.010, Grant County, a political subdivision of the State of Washington, acting through its Board of County Commissioners, recognizes the benefits of transferring jurisdiction of portions of county roads and right-of-ways, namely that portion of R-NW as described below and as shown in Exhibit A;

LEGAL DESCRIPTION:

THAT PORTION OF R-NW ROAD Roadlog 93025 MP 0.693 to MP 1.05, located at the eastbound 11 NW roadlog 32780; OF Section 12 T20N R 23 E.W.M AND Section 07 T20N R 24 E.W.M., ALL IN GRANT COUNTY, WASHINGTON.

WHEREAS, Grant County Public Works and the City of Quincy have previously agreed to work towards the transfer of jurisdiction of said Right-of-Way, and




