RE: UTC 2025-27 BUDGET REDUCTION PROPOSAL

On behalf of the Utilities and Transportation Commission (UTC), please accept the attached worksheet as our response to the budget savings options exercise distributed January 24, 2025.

In preparing the attached worksheet, the Commission analyzed its existing statutory requirements and the programs performing that critical work, with a focus on protecting the people in the state by ensuring investor-owned utility and transportation services are safe, equitable, available, reliable, and fairly-priced.

While the work performed by the Commission is resource intensive and offers little opportunity for broad reductions, staff was able to identify areas in the budget that allowed us to meet the directed 6% savings. Examples of the complex, statutorily required work performed by the Commission include:

- Full docket of rate proceedings across all regulatory portfolios;
- Proceedings to review utility clean energy implementation plans;
- Examinations of costs related to wildfire planning;
- Energy markets, storage, and double counting;
- Consumer protection for household goods movers, telecommunication companies and utilities;
- Inspections and investigations for motor carriers, pipeline operators and railroads; and
- A leadership role in regional discussions regarding transmission planning, resource adequacy, and developing regional electricity markets

As Governor Ferguson stated recently in his appointment announcement for our new Chair, Brian Rybarik, "Washingtonians are impacted every day by the availability and safety of electricity, telecommunications, natural gas, water and transportation...as Washington advances forward on a clean energy transition."
