Subject: 6% Operating Budget Reductions

The Washington State Conservation Commission (SCC) implements vital incentive-based programs that provide funding for technical assistance and implementation of conservation projects to achieve effective, multi-benefit solutions for our most pressing natural resources while also creating jobs and driving economic activity.

SCC recognizes that current revenue forecasts, increasing costs, and growing caseloads require cuts to achieve a balanced state budget. We take the Office of Financial Management's directive to cut 6% of our General Fund Operating funding seriously and appreciate the opportunity to participate in this decision-making exercise.

SCC's small budget provides limited opportunity for budget reductions that will not entirely eliminate the utility of individual programs. Out of our \$16.9 million operating budget, more than 80% is passed through to local conservation districts. This funding pays conservation district staff salaries in local communities, keeps the lights on at conservation districts, enables conservation districts to serve their communities, and drives locally-led conservation of natural resources across Washington. Any cuts to funding will have compounding effects in local communities across our state at a time when the future of federal funding is uncertain.

The remaining 20% of operating funding, supports agency operations. With a staff of only 35 FTE's, any cuts to staffing will have significant, long-term impacts on the agency's ability to function. We have historically been understaffed and are in the process of aligning resources and staff capacity to best meet agency objectives and obligations. Additionally, any cuts to staffing will negatively impact the remaining staff's ability to be successful in their roles.

None of the proposed cuts were easy decisions to make. These cuts will impact specific programs and agency functions but allow us to maintain resiliency and minimize the

impacts on SCC and conservation district services. We have attempted to limit the impact to local communities and conservation districts in our proposal. The enclosed spreadsheet details our proposal.

Thank you for your ongoing support and collaboration in managing our budget. We appreciate your efforts in reviewing budget adjustments.
